Nomination for Second Vice President

The Second Vice President is an officer on the Board of Directors and a member of the Affiliate Council of the National Environmental Health Association. This national officer moves in succession from Second Vice President to First Vice President to President-elect to President to Immediate Past President.

The candidate must be:

- Be a regular or life member of NEHA with at least three years of cumulative membership
- Each nomination is accompanied by five signatures of voting NEHA members, in which three of the five members represent different affiliates, and
- Nominated persons are qualified according to the Articles of Incorporation and Bylaws and are willing to faithfully serve.

This form and any supporting material to the NEHA Nominations Committee must be received in the NEHA office **no later than December 1** prior to the AEC in the year he or she is being considered for nomination.
